

## REGISTRATION POLICY | DELEGATES & LIFE PARTNERS

Before you register for the 2024 Count National Conference, please familiarise yourself with the registration policy. This policy covers registration fees, cancellations, and the code of conduct.

### DELEGATE

A delegate is identified as a member of the Count network inclusive of Count Equity Firms, Count AFSL, Affinia AFSL, future members and any guests. This includes both Authorised Representatives and Non-Authorised individuals. A Non-Authorised Member is classified as an Accountant, Principal, Paraplanner and Operational Staff. Delegates are required to pay a registration fee to attend the conference.

### LIFE PARTNER

Life partners are welcome to attend the 2024 Count National Conference if accompanied by a registered delegate.

A delegate may register their life partner during their registration. There is no charge for life partner registration which includes access to keynote sessions, but not plenary and business sessions. Additional fees will apply if your life partner wishes to attend any of the social events and/or the Partner Program.

### FAMILY POLICY

The 2024 Count National Conference is a business event; therefore, children cannot be accommodated as part of the conference events, sessions, and activities.
